**TYPE 1A: Speed Runs, Poker Runs and Radar Runs
less than 500' on grass or less than 660' on
ice or snow. Single runs only.**

**TYPE IB: Speed Runs, Poker Runs and Radar Runs
more than 500' on grass or more than 660'
on ice or snow. Single runs only.**

**TYPE 2: Drag Racing and Mountain Cross - head
to head racing With each snowmobile in
its own lane. Hillclimb events 75% of
Drag Racing Program.**

**TYPE 3: Oval, Enduro, Sno-Cross,
Hillcross,
s, Ice Lemans, Lake Enduro and limited
Cross Country. - Closed course racing
where officials observe entire course.**

**TYPE 4: Cross Country and Lake Endures or any uncontrolled
course where observe entire course.**
